Eligibility

This is a drawing competition open to US artists, 18 years and older. Entries are limited to representational, fine art drawings executed in a single color (plus white, if artist wishes), on paper (colored or white). Media is confined to one of the following: pencil, conté crayon, charcoal or . Colored pencil and pastel work (with the exception of drawings done with a single color) will not be accepted. **Class and supervised work, abstracts, prints and copies (including giclees) ARE NOT permitted. Please, no frontal nudes. The center hosts children’s art classes.**

Jury Process

Jury is by digital file submission only. Entrants may submit up to three images for consideration. **Please do not**

submit images of any work that is not available for display. If you are accepted and withdraw your piece, you will not be able to exhibit in an AFAL exhibition for two years. No substitutions will be accepted. Size requirements are NO LARGER than 40x40 FRAMED with the width (top & bottom) being NO LARGER than 40 inches. This means the outer measurements of your frame.

PLEASE NOTE:

ALL DIGITAL IMAGES WILL BE PRINTED FOR COMPARISON TO EACH PAINTING FOR ACCURACY. IF THEY DO NOT MATCH THEY COULD BE REJECTED.

Image Requirements

Please use a non-smearing pen when labeling CD. When emailing or mailing a digital file make sure the image is right side up. Please make all digital entries RGB/.jpg format, 300 dpi resolution and 900 pixels the longest dimension. In the body of the email or on the CD indicate the title, medium and size of the artwork as well as the dimensions of the outer portion of your FRAME. Only the canvas image should be seen in the image. When saving your image make sure it is labeled as **YourLastName.Title.jpg**.

EXAMPLE:

Framing Requirements

All accepted work must be properly framed, wired and labeled and have a suitable backing-paper, cardboard, foam

board, etc. No clip frames will be accepted. Juried work will not be hung if it does not meet these guidelines. On the back of each painting, attach a 3x5 card to the top right hand corner with your name, title, medium, price and phone number.

Delivery and Hanging

Accepted work must be delivered between 10 AM and **NO LATER** than 1PM, Tuesday, August 10, 2010.

Shipped Artworks

Out of town entries that are accepted will receive detailed information regarding shipping.

- A fee of \$45 for one painting in one box or \$50 for two paintings in one box will be required for all shipped entries to cover unpacking, delivery, pickup and repacking of artwork only. Return shipping instructions will be included in the detailed information if you are accepted.
- No glass will be accepted for shipped work. Plexi-glass only.
- Artist is responsible for insurance.
- Shipping Agent will accept and return boxes from ANY shipper (UPS, FEDEX or USPS)
- Shipped works must arrive at the shipping agent during the week of August 2-7, 2010. Accepted artists will receive shipping instructions along with their acceptance form.

Removal of Work

Work is to be removed on Saturday, October 2, 2010 between 11AM & 2PM. No paintings or sculptures may be removed prior to that time. Please inform your client or gallery of the time frame in which the painting will be on view.

Insurance

The Roswell Visual Arts Center (RVAC) carries no liability insurance and assumes no responsibility for the safekeeping of the artwork. The Artist agrees to release the Roswell Visual Arts Center & the Atlanta Fine Arts League, Inc. from all liability including, but not limited to, liability for personal injury, theft of/or damage to the artwork, or the theft of/or damage to the collection or the proceeds from its sale.

Sales

The RVAC will retain a commission of 30% for any sales during the show.

Rights

AFAL and the RVAC reserve the right to photograph and retain a set of images of the exhibit.

Entry Fees

Entries that DO NOT adhere to the guidelines in this prospectus will not be judged.

- **MAIL** entry as a CD along with your completed **jury form** in its entirety, **entry fee**, a **self-addressed STAMPED legal-size**

envelope for return of jury form and shipping instructions. CDs will NOT be returned. Please make sure you use proper postage on your return envelope. **Please DO NOT send entries via Fed-Ex, UPS, or overnight mail where a SIGNATURE IS REQUIRED for your package WILL NOT BE PICKED UP AT ANY MAIL FACILITY.**

JUROR **Suzy Schultz**

Atlanta artist Suzy Schultz has little formal art training, but was exposed to art at an early age through her mother, who is a painter. She graduated from Auburn University with a degree in mathematics and taught high school for 4 1/2 years. Taking a leave of absence, she spent a year overseas with Campus Crusade's Short-Term International program in Poland. On returning, she did some part-time graphic design work for Mission to the World, and was eventually hired to help with their publications. There she was mentored and nurtured in her artistic talent, and encouraged to paint for illustrations used in the magazine. When her mentor and boss left to go on the mission field six years later, she was told she needed to leave her job and paint full time, which she did.

She has painted full-time since 1996, and has won many awards for her work. Schultz is the winner of the Gold Award from Watercolor Magic magazine's Watermedia showcase (chosen from 2,400 entries), and was featured in their August 2006 issue. Her work has also received an Honorable Mention in the portrait category of Artist's Magazine's 2001 issue (out of 13,000 entries), and was featured in the Spring 2006 issue of Drawing magazine. She has also had work published in art books by Rockport Publishers and International Artist Publishers, and recently had work featured in "Strokes of Genius II", Northlight Publishers.
